1. Complete this application form and email, mail, or deliver it to the Chief Election Officer at elections@dnv.org, or 355 West Queens Road, North Vancouver BC V7N 4N5.
2. If your application is complete and you qualify to vote by mail ballot, a mail ballot package will be sent to you as soon as the ballots are available. If we receive your application after September 23, 2026, the time may be insufficient for mailing and receipt of the ballot; we recommend that you arrange to pick up a mail ballot package from the District of North Vancouver Municipal Hall. Mail ballots will not be issued after October 2, 2026.
3. You are responsible for ensuring that your completed ballot and documents are received by the Chief Election Officer by October 17, 2026 before the close of voting at 8 p.m.
