1. Welcome

8. Accessibility Plan (City of North Vancouver)

Staff provided a presentation on the City of North Vancouver Accessibility Plan. The Accessible BC Act came into effect in 2021 and requires public sector organizations to develop and publish:

- An Accessibility Plan to identify, remove, and prevent barriers
- An Accessibility Advisory Committee
- A feedback mechanism to report barriers.

The plan was developed with input from members of the former North Shore Accessibility Advisory Committee in Disability Issues; feedback from disability service organizations such as:

- Canadian National Institute for the Blind
- North Shore Community Resources
- Intellectual Disabilities Society
- North Shore Disability Resource Centre
- Spinal Cord Injury BC

And staff groups such as:

- Accessibility Working group
- Steering group
- Employee Resource group

The City of North Vancouver Accessibility Plan guiding principals are as follows:

- Clarity First
- Accessible
- Learning Focused
- Action Oriented
- Collaboratively Informed
- Achievable Goals
- Build on Existing Work

Next Steps and Opportunities are as follows:

- Action plan implementation and integration
- Staff training and capacity building
- Community engagement and collaboration
- Monitoring progress and reporting back

Ongoing review and updates

On completion of the presentation, the following comments were provided:

- In terms of staff training, there is a plan and part of the training that will be open to all staff will be ableism, disability inclusion, disability etiquette and a pilot training was launched this year which included sign language classes. In addition, there will be training for specific groups such as employees that serve the public and members of the communications team. with different learning elements tailored to each group.
- Accessible parking spaces are considered in the Curb Access & Parking Plan and includes increasing the number of accessible spots and improving the options for pick ups and drop offs. A presentation will be provided to the committee possibly at the September meeting.
- There is still an opportunity to provide recommendations for the accessibility plan and the recommendations will be considered as part of the plan's future updates.
- A question was raised on whether committee members could provide analysis of the
 plan including a comparison with other municipalities, and whether it may be
 appropriate to share the results of the analysis with the committee, or with the City of
 North Vancouver DEI Leader. Staff responded that the City of North Vancouver would
 like to review the analysis and that the results of the analysis could be shared with the
 committee.

9. Next Steps

Committee members requested that the following items be further explored:

- · Accessible toilets as this is a significant issue for people with disabilities
- Accessible washrooms at Phibbs Exchange.
