


# Understanding where your Property Tax and Utility Fees go

Did you know 32.6% of property tax and utility fees collected goes straight to the Province and other agencies for things like schools and transit? The District has no control over taxes charged by other authorities.

The District uses 40.9% of payments collected to fund core services such as public safety, transportation, parks and recreation, and investments in housing and infrastructure.

Utility fees make up the remaining portion of your bill. Utility fees cover essential services such as water, sewer, and waste collection and are split between Metro Vancouver and the District. See page 3 for more information.



# These are some significant projects the District is investing in:

- Affordable and supportive housing:
   582 units in progress
- Active transportation projects connecting neighbourhoods and village centres, transportation improvements, and upgrades to existing municipal roads and structures
- New turf fields at Inter River Park and Handsworth Secondary, plus converting two gravel fields to turf
- New parks in Lynn Creek and Lynn Valley town centres, new park washrooms, and upgrades to Myrtle Park
- Improving community spaces such as libraries and community recreation centres

# Your Property Tax and Utility Notice at a glance

When you look at your property tax and utility notice, it can be broken down into three main categories:

Taxes set by and collected for other public authorities

Levies collected on behalf of the Province (school taxes), Metro Vancouver, TransLink, BC Assessment and Municipal Finance Authority of BC.

Municipal taxes set by Council

Annually adjusted levies for municipal services like public safety, transportation and infrastructure replacement and community services.


Utility user fees

Fees for water, sewer, garbage and recycling. Around half (48%) of this fee goes directly to Metro Vancouver to provide clean drinking water, wastewater treatment and solid waste management. The District uses the other half for utility system and infrastructure maintenance and upgrades.

Only 1 and 2 are based on your property's assessed value.

## A closer look at utility fees

Utility fees are separate charges for your property's water, sewage and waste collection services. Unlike property taxes, utility fees cannot be deferred through the Provincial deferment program and must be paid each year.

## **Water and Sewer**



Your annual water and sewer fees are determined by Metro Vancouver service fees and the District costs

for providing current service levels and maintaining the condition of existing infrastructure. See charts on right.

Metro Vancouver's annual utility fees are projected to rise significantly over the next half-decade as it replaces aging infrastructure, including the new North Shore Wastewater Treatment Plan being built to serve the District of North Vancouver, City of North Vancouver, District of West Vancouver and Skwxwú7mesh Úxwumixw (Squamish Nation) and səlilwəta+ (Tsleil-Waututh Nation).


## Solid waste management

Your utility bill also includes the cost of



weekly garbage, organics and recycling collection. We collect 8,000 garbage and organics carts daily across the District.







## Wet weather pricing

In 2024, Metro Vancouver introduced wet-weather pricing, an additional fee charged to municipalities over and above the current yearly levy to cover wastewater services, which includes costs for the wastewater treatment plant and the regional sewer system. This new wet weather pricing levy charges municipalities for the sewer capacity used during the rainy season to contribute to the system's overall operation and maintenance and will be phased in over the next 10 years. These costs are recovered as part of utility user fees charged to property owners.

## Possible impact of North Shore Wastewater Treatment Plant increased cost

We understand you may have concerns about how the cost of the new wastewater treatment plant may impact your property taxes and utility rates now and in the future. We don't have all the information at the time this newsletter has gone to print, but we do know that cost increases for residents are scheduled to begin next year in 2025.

We continue to advocate for a fair and transparent solution for our residents. We are also encouraging Metro Vancouver to reengage with senior levels of government for additional project funding.

At a Metro Vancouver budget meeting in April, Mayor Mike Little appealed for all member municipalities—not just North Shore residents—to share the burden of the wastewater plant's skyrocketing costs, as the cost increase is too much for North Shore residents to bear alone.

Metro Vancouver's board is expected to resume discussions at its meeting in late May.



## FAQ

## Can you reverse my late payment penalty?

Unfortunately, we cannot. We must follow Provincial legislation and apply a penalty on any outstanding amount after the due date. There is no exception.

# What is the utility billing cycle for residential properties?

Unlike other municipalities, which bill their utility fees separately earlier in the year, the District flat-rate utility charges are billed as part of the yearly tax notice.

### If there is a balance owing on my Preauthorized Payment Plan will the District take the remaining balance from my bank account?

Our current Pre-authorized Payment Plan (PAWs) is for a 10-month payment plan from August to May. There is no withdrawal in June and July. Homeowners must pay the remaining tax balances by the due date.

## If I defer my taxes, do I need to pay any other fees?

If you choose to defer your taxes, it's important to understand that this only applies to the tax portion of your notice. You are still responsible for paying your utility fees to the District and claiming your home owner grant, if eligible.

## Programs to help you pay your taxes

#### **Claim Your Home Owner Grant Online**



Eligible residents may claim their home owner grant by applying directly with the Province at **gov.bc.ca/homeownergrant**. If you need assistance, call the Province at 1-888-355-2700.

## **Defer Your Property Tax Online**



You may be eligible to defer all or part of your property taxes. Submit property tax deferral applications online at **gov.bc.ca/propertytaxdeferment**. Please note that you are required to pay your utility user fees to the District. Claim your home owner grant if you are eligible even if you defer property tax payment.

## Receive your property tax notice electronically

## **Property Tax Calculator**

Visit My Property Tax Calculator at app.dnv.org/PropertyTaxCalculator to view information specific to your residential property and determine how your change in assessed value and property tax compares to the District average.

## **Penalties**

Payments must be received by July 2, 2024, to avoid penalties. A 5% penalty is applied after July 2, 2024, and an additional 5% after September 3, 2024. No forgiveness of late penalties is permitted under provincial legislation.
